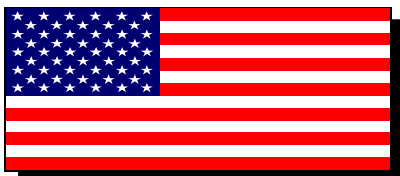


SICK BAY:
