**FOOD PANTRY DONATIONS**

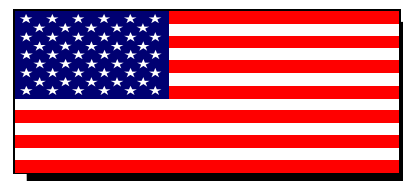
